5. PRESENTATIONS

- 5.1 Wellness Center Events and Programming Update (Armando M. da Silva)
 - (Last Saturday) Family Dance Party July SNL event; new event, glow party/face paint/cotton candy; 8-10pm.
 - Upcoming Kids Night + Movie in the Park on Friday, July 26, 2024.

Armando goes over attendance for Dive In Theater events and movies in the park. Ivet asks about the cancellation of the July 12 movie in the park; Armando and Stephanie explain that it was cancelled due to

the extreme heat that day and will be rescheduled to show the movie during the National Night Out event on August 6th as a pool event. Ramiro asks about using CivicRec for public swim; Stephanie and Armando talk about how much more efficient it is than just using the sign-in sheets to gauge attendance. Evening swims are better attended than afternoon sessions. Will keep in mind for scheduling for next season. Armando discusses upcoming fall events (Floating Pumpkin Patch, Food Truck Takeover) and talks about other ideas for fall (Senior dances with a live band, Monday Night Football at the WC). He also discusses adding more fitness classes and introducing other types of classes and workshops, from arts/crafts to health lectures and medical informational presentations.

- 5.2 Wellness Center Memberships Update (Stephanie Velasquez)
 - Stephanie talks about membership growth for the Wellness Center facility from May to
 present; she and Armando update committee on the new software and how has been more
 accurate at reporting membership sales and other data. Still in the process of transferring
 completely all of the recurring memberships; she discusses the setbacks they've had with
 the software, but also highlights the vast improvements in efficacy for both staff and
 users.
- 5.3 Wellness Center Facility Improvements/Capital Outlay Projects Update (Armando da Silva)
 - Armando updates on recent installation of the roof access ladders by Doug DeLeo Welding, which will make roof access safer and easier. This project came in under budget. He also talked about the replacement of all hardware fixtures in the restrooms, and the water fountains, both of which are holding up nicely after installation of the water softener which cut down on the buildup which was breaking down the hardware before. Armando updates on VFD (install planned for September) and security cameras (will request funds increase from Hospital Board since we didn't receive the grant for funding. Discusses placement of 10 cameras in/around facility.

 - 2. Pre-fab concrete skate park.
 - 3. Sand volleyball courts next to skate park (Kiwanis, \$15K in materials.)
